




## How Data Management and Data Governance Overlap Definitions

- Data Governance The execution and enforcement of authority over data.
- Data Management A cohesive set of disciplines focused on delivering quality data and information.
- Data Stewardship Formal accountability for data.
- Data Steward A person held formally accountable for their relationship to the data.
- Metadata Data that improves both the business and technical understanding of the data.
- Metadata Governance The execution and enforcement of authority over metadata.
- Metadata Steward A person held formally accountable for their relationship to the metadata.






#### Data Management

- "Data management is a cohesive set of disciplines focused on delivering strategic data with quality and confidence." (Robert S. Seiner)
- "Data management is the development, execution, and supervision of plans, policies, programs, and practices that control, protect, deliver, and enhance the value of data and information assets." (DAMA-I)
- "Data management encompasses the practices, architectural techniques, and tools for achieving consistent access to and delivery of data across the spectrum of data subject areas and data structure types in the organization." (Gartner IT Glossary)







- Data Management
  - "Data management is a set of disciplines that support the management of data as a valued resource of the enterprise, and includes the processes for data quality, master data management, metadata management, and data integration." (TDWI)
  - "Data management is the development, execution, and supervision of plans, policies, programs, and practices that control, protect, deliver, and enhance the value of data and information assets." (IBM Data and AI Learning Path)







#### Data Governance

- "Data governance is the execution and enforcement of authority over the definition, production, and usage of data and data-related assets." (Source: Robert S. Seiner)
- "Data governance is the specification of decision rights and an accountability framework to ensure appropriate behavior in the valuation, creation, storage, use, archiving, and deletion of data. It includes the processes, roles, standards, and metrics that ensure the effective and efficient use of information in enabling an organization to achieve its goals." (Gartner IT Glossary)
- "Data governance encompasses the people, processes, and information technology required to create a consistent and proper handling of an organization's data across the business enterprise." (Data Governance Institute)





- Data Governance
  - "Data governance is the exercise of decision-making and authority for data-related matters, and it includes the processes, roles, standards, and metrics that ensure the effective and efficient use of data and information in enabling an organization to achieve its goals." (DAMA-I)
  - "Data governance is a system of decision rights and accountabilities for information-related processes, executed according to agreed-upon models that describe who can take what actions with what information, and when, under what circumstances, using what methods."
    (IBM Data and Al Learning Path)





- Scope and Focus
  - Data Management
    - Operationalizes aspects of managing data through its lifecycle.
    - Processes and technologies efficient and effective handling of data.
  - Data Governance
    - Strategic and organizational focus.
    - Behavior aspects of data management.
    - Core components Data, Roles, Processes, Communications, Metrics, and Tools







# How Data Management and Data Governance Overlap Defining the Function of Each Discipline

- Activities
  - Data Management
    - Operational aspects of handling and maintaining data.
    - Data collection, acquisition, storage, organization, quality management, integration, documentation, security, privacy, analytics, insights, archiving, retention, ...
  - Data Governance
    - Behavioral aspects of handling and maintaining data.
    - Data framework, policies, stewardship, committees and teams, standards, incorporating metadata management, ensuring compliance, risk management, fostering literacy, ...
    - Consistent, compliant, responsible handling and maintaining of data.





# How Data Management and Data Governance Overlap Defining the Function of Each Discipline

- Implementation
  - Data Management
    - Execution of processes, technologies, practices, to effectively handle and maintain data.
    - Databases, data warehouses, data lakes, analytical platforms, ...
    - Data integration, quality, storage, retrieval, security, process and workflows, ...
  - Data Governance
    - Execution and enforcement of authority over the definition, production, and use of data.
    - Framework, structure, roles and responsibilities, policies, best practices, standards, ...
    - Data stewardship, ownership, accountability, authority, escalation, resolution, ...





    - Data Governance Councils, Subject Matter Experts (SMEs), Stewards, Partners, ...










- Does It Matter

  - The chances are that the similarities and differences need to be clearly articulated.












