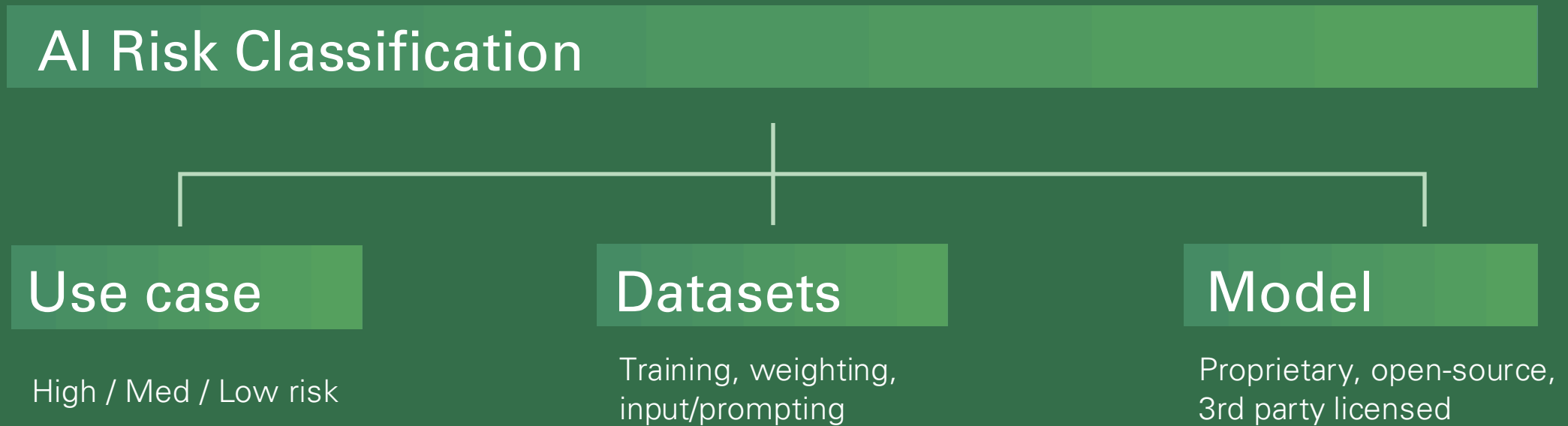

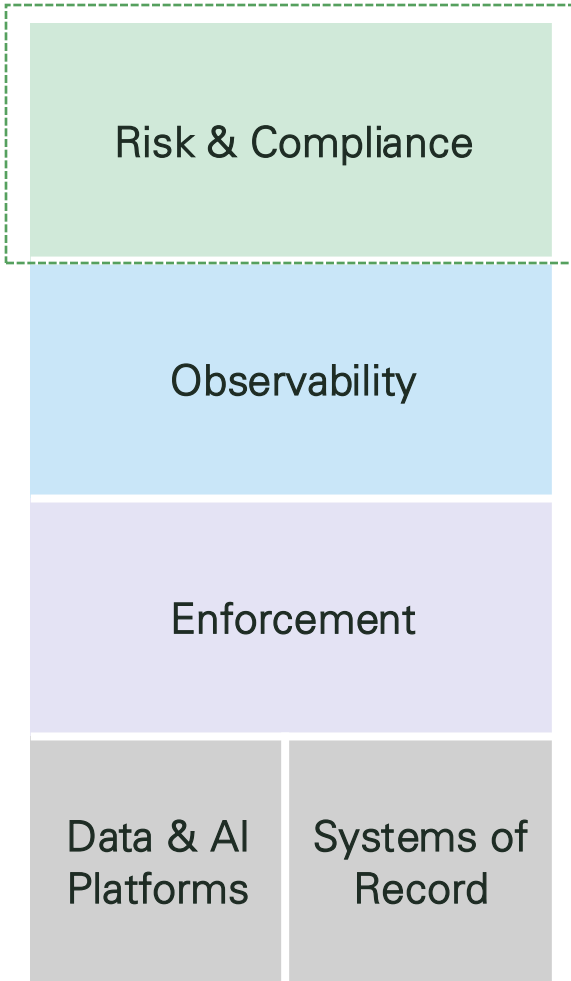
The AI Governance stack

No single layer is sufficient; effective governance spans people, process, and systems

The AI Governance stack

Governance must evolve with AI, not lag behind it

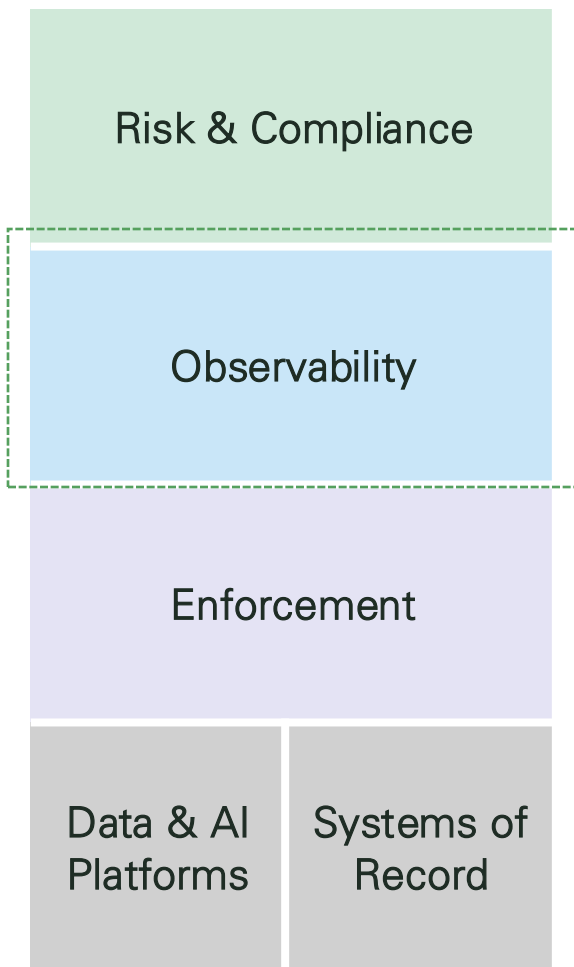


Challenges:

- Disconnected from AI behavior and state
- Manual workflows increase overhead
- Documentation is stale without runtime context

The AI Governance stack

Effective governance is not limited to model monitoring in isolation, undocumented decisions, and unprioritized issues

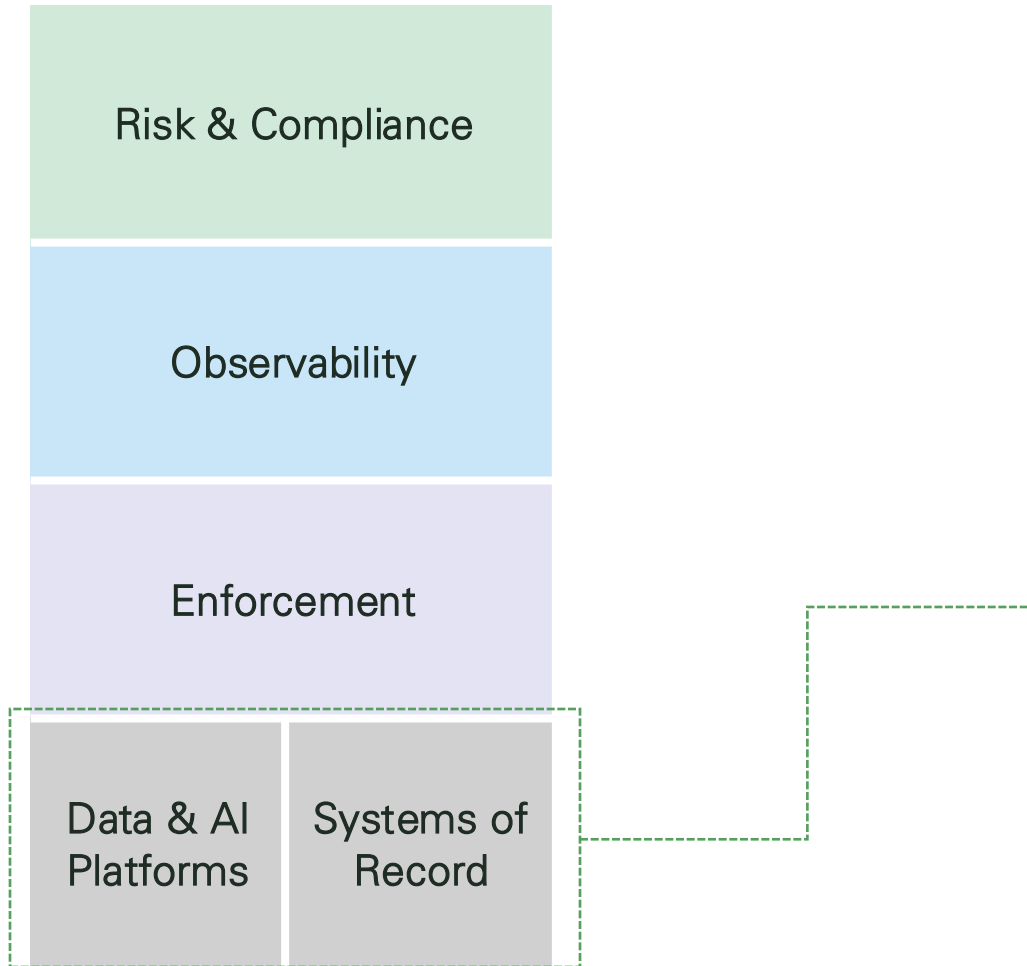


Challenges:

- Business risk not reflected in model management
- Siloed tools for drift, bias, and lineage create visibility gaps
- No feedback with compliance and risk owners

The AI Governance stack

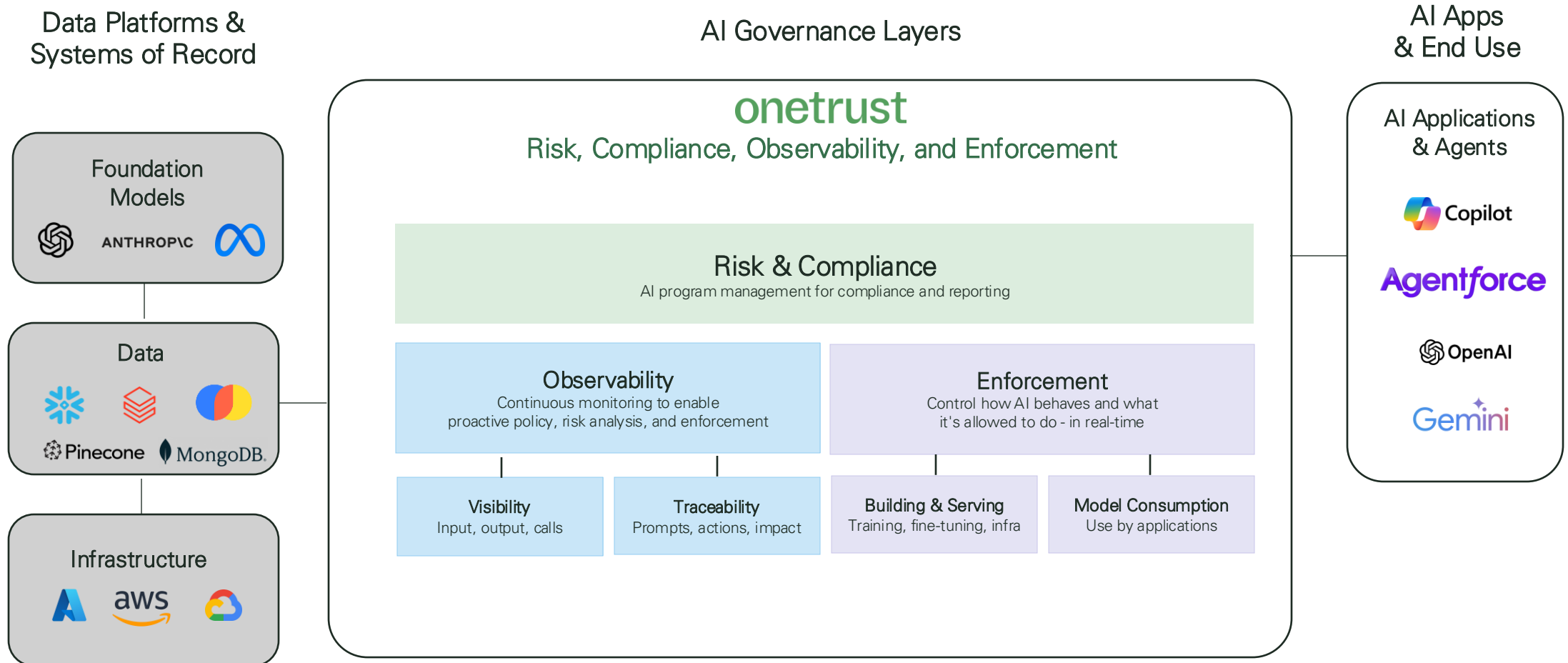
AI is built, deployed, and embedded everywhere—often without oversight



Challenges:

- AI adoption outpaces governance coverage
- Accountability is limited to resource management
- No ties to risk, policies, and compliance
